



Room Layout and Assignments

Our Plenary Speaker: **Dr. James C. VanderKam** John A. O'Brien Professor of Hebrew Scriptures University of Notre Dame

Our plenary speaker earned his PhD from Harvard University (Near Eastern Languages and Civilizations) in 1976. He taught religion at North Carolina State University from 1976-1991. In 1991 he was appointed Professor of Hebrew Scriptures at the University of Notre Dame. In 1998 he was installed as the James A. O'Brien Professor of Hebrew Scriptures. Dr. VanderKam's publications in biblical and Qumranic studies are prolific. Significant publications pertaining to the Oumranic materials include the following: The Book of Jubilees (1989; 2 vols), Calendars in the Dead Sea Scrolls (1998); The Book of Jubilees (Guides to Apocrypha and Pseudepigrapha; 2001), An Introduction to Early Judaism (2001), The Meaning of the Dead Sea Scrolls (with Peter Flint, 2002), and From Joshua to Caiaphas: High Priests after the Exile (2004). Perhaps Dr. VanderKam's most widely known work is The Dead Sea Scrolls Today, which was published in 1994 and has been translated into six languages. A second edition is now in preparation. One of Dr. VanderKam's most significant and enduring contributions to Qumranic studies is the editing of more than a dozen volumes of Discoveries in the Judean Desert. Most recently, Dr. VanderKam has completed his commentary on 1 Enoch 72-82 (Hermeneia Series). Currently, Dr. VanderKam serves the Society of Biblical Literature as the editor of the Journal of Biblical Literature, a position he has held since 2006.

The title of Dr. VanderKam's lecture is "The Scrolls and the Scriptures." We welcome Dr. VanderKam to the Central States SBL meeting.

Brad Chance called the meeting to order about 12:20. The minutes for last year were approved, with the motion offered by Jim Moyer and seconded by LeMoine DeVries.

Announcement for next year's meeting: March 30-31, 2008 at the same location. Chance noted a problem with dates stated in the contract, but said he would get it corrected, which he did, following the meeting. There was some brief discussion about changing venues in the future, perhaps to a college, but the consensus seemed to be that a central location was more convenient.
