

Keynote Speaker for the 2018 Meeting:

Dr. Barbara R. Rossing

Professor of New Testament Lutheran School of Theology at Chicago

Title: "Ecology and the Book of Revelation"

BARBARA R. ROSSING is Professor of New Testament at the Lutheran School of Theology at Chicago, where she also directs environmental initiatives. She currently chairs the Ecological Hermeneutics Section of the Society of Biblical Literature, and has served on the steering committees of the SBL "Bible and Popular Culture" and "John's Apocalypse and Cultures Ancient and Modern" sections. An avid environmentalist, Rossing received the bachelor of arts degree in Geology from Carleton College, the master of divinity degree from Yale University Divinity School and the doctor of theology degree from Harvard University. She is the author of *The Rapture Exposed: The* Message of Hope in the Book of Revelation, The Choice Between Two Cities: Whore, Bride and Empire in the Apocalypse, and articles and book chapters on Revelation and ecology, including "Revelation" in the Fortress Commentary on the New Testament. Her interdisciplinary work on apocalyptic eschatologies and intersections with religion and science has been supported by fellowships from the Association of Theological Schools, the Henry Luce Foundation, the John Templeton Foundation, and The Enhancing Life Project of the University of Chicago.

Minutes

Business Meeting of Central States Regional SBL/ASOR March 13, 2017

- 1. Horne called meeting to order. There were seventeen (17) members present. Horne noted Benz's regrets for absence, but had to return Dan Fleming to the airport in Kansas City early to avoid winter storm in upper Northeast.
- 2. Adopted the minutes with the budget report from the previous year (see program), including balance on hand as of Jan. 2017.
- 3. The agenda was as follows:
- a. Evaluation of Stoney Creek hotel. The cost was comparable to last year's stay at the Marriott in St. Louis. Everyone voiced approval. Would like to return, pending affordability. All liked the location, especially those from Springfield and Kansas City. Wondered why there were not more from the central part of the state.
- b. Noted that next year NT is sponsoring our plenary speaker. First choice for next year is Barbara Rossing from Lutheran School of Theology in Chicago; second choice is Margaret Mitchell from University of Chicago.
- c. Low attendance this year. All were concerned and made suggestions for next year: a. let out another RFP for competing hotels in the area: competition never hurts and probably will help; b. recruit personally for more member-scholars (as opposed to student scholars alone) to attend and present papers. Shared Dan Fleming's suggestions that sections hand pick presenters for their sections.; c. choose popular appeal in plenary speakers, like Barbara Rossing (though not everyone in the room had ever heard of her). Still, NT is likely to draw a larger crowd.
- 4. Adjourn.
