



## SBL Green Open Access Permission Request

Academic, peer-reviewed publishing uniquely serves higher education by setting standards, vetting content and methodology, and disseminating research. Such publishing also is a means of professional development by providing credentialing for tenure and promotion. Thus, academic publishers are an essential component of the higher education ecology. In this ecosystem, the stakeholders—scholars, institutions, publishers, libraries, learned societies, and public and private funding agencies—support each other’s role to create a long-term and sustainable system that promotes collaboration and communication.

In order to foster biblical scholarship and scholarly communication, the Society of Biblical Literature allows specific and reasonable dissemination of the results of scholarly research published within its books and journals. By completing and signing this permission request form, the author indicates that he or she has read, understands, and agrees to abide by the SBL Green Open Access policy provided in Appendix A below.

## APPENDIX A

### General Policy

The SBL endorses a Green Open Access (GOA) policy. This policy allows the author to post or archive a PDF file of the postprint manuscript in specified types of open-access locations—the author’s institutional repository (IR) and the author’s personal or institutional website—following an eighteen-month embargo from publication date. The complete article citation must be provided as specified by SBL.

### Policy Details

1. The author must request permission to post the article through the SBL Green Open Access Agreement Form, which will be provided as part of the publishing agreement, will be available online for electronic submission, or can be requested at any time.
2. Permission to post a **postprint manuscript** may be requested at any time, provided that open-access availability is delayed until **eighteen months after first publication** in the journal or book (print or online).
3. Any posting of an SBL-published work must acknowledge the SBL’s copyright of said work and the source of the original publication. The wording of this citation will be provided by SBL in the GOA Agreement.
4. The SBL GOA policy applies only to articles and book reviews published in an SBL journal, whether print or online, and to essays in an SBL-published multi-author work. It does not extend to singly authored monographs, and the public dissemination of any book-length SBL publication is expressly prohibited.
5. The SBL grants the right to post an SBL-published article or essay only to the authors of the work, who may then provide the published work to the author’s employer or sponsoring organization. Authors may not authorize any other third party to post an author’s SBL-published work on the Internet and should refer any inquiries of this sort to the SBL Publications office.
6. For works authored by more than one person, the right to post the work publicly extends equally to each author, provided that all the authors of the work agree to the open-access dissemination of the material.
7. The grant of rights under this policy applies only to an author’s personal website or to the official website of an author’s employer or sponsoring organization. This policy does not, at this time, extend permission to post an article or essay on any other aggregated site or portal, such as academia.edu or the Open Library of Humanities. Other sites should rather link to the permitted archival locations.
8. If an author is employed by multiple institutions (as adjunct, lecturer, visiting professor, or scholar in residence), an article or essay may be archived in multiple IRs.
9. For IRs, an archived or posted article may include a link to the published journal article (publisher’s copy) in the institution’s online databases only if access to the online library database is protected and available only to members of the institution.
10. The author and the institution bear responsibility for checking the contractual status of material in an article that has rights and permissions associated with it and that may be required in the article’s pre- or postprint manuscript form.
11. An institutional repository will have permission to archive and display a permissible article after that institution no longer employs the article’s author.

12. This policy does not include permission to reuse or publish an SBL-published work in any form, whether print or electronic, whether for profit (commercial use) or not for profit, nor does it authorize the author or the author's institution to license or give permission for the reuse or republication of that work to a third party.
13. The publisher's copy, namely, the PDF offprint authors receive, may not be posted at all.
14. By granting authors permission to make available their SBL-published work on the Internet, SBL does not relinquish any of its rights as the copyright holder.
15. Any open-access questions not addressed by this policy should be referred to the SBL Publications office.
