

J. Ross Wagner (Ph.D., Duke University) is Associate Professor of New Testament at Duke Divinity School. Specializing in Paul's letters and in Septuagint studies, he seeks to contribute to the recovery of theological exegesis through careful investigation of the ways scriptural interpretation shaped early Jewish and Christian communities. His publications include *Heralds of the Good News: Paul and Isaiah in Concert in the Letter to the Romans* (2002), *Between Gospel and Election: Explorations in the Interpretation of Romans* 9–11 (coedited with Florian Wilk, 2010) and, most recently, *Reading the Sealed Book: Old Greek Isaiah and the Problem of Septuagint Hermeneutics* (2013).

Minutes of Business meeting Central States SBL, March 17-18, 2014 St. Louis, Missouri

Minutes

The meeting was held at the St. Louis Marriott West, March 16-17, 2014. Total attendance was 69, of which 52 were preregistered and 17 were registered onsite. Of the 69, 32 were members registered for two days, 7 were non-members registered for two days, and 30 were students registered for one day.

The section leaders were: Mark Given for New Testament, David Chapman for ASOR, Roger Cotton for Hebrew Bible/Old Testament, Deborah Krause for Gender and Religious Studies, and Kristin Swanson for Pedagogy. The keynote plenary speaker was Dr. Carol A. Newsom of Emory University, who spoke on the topic: "At Home or Homeless? The Wisdom Tradition and Contemporary Philosophy on the Problem of Evil." The book display included Eerdmans, Fortress, Zondervan, Baker, Westminster/John Knox, Concordia Publishing House, Paulist Press, Hendrickson, and Society of Biblical Literature. There were 40 individual papers presented in the various sections, plus a student panel on effective teaching and learning, and 3 papers for the Theta Alpha Kappa Honor Society. New officers were affirmed: Horne as Regional Coordinator, Raabe as Treasurer, and Cotton as OT section coordinator. For the past two years the Central States regional has been running in the red and eventually will use up our balance. The net loss for 2013 was \$520.16 and for 2014, \$382.98. The balance in the checking account as of October 2014 is \$7315.33.
