### **IMAGINE:**

#### **Looking around the Corner to 2008**

It is hard to imagine a Society of Biblical Literature without the website, the *Review of Biblical Literature*, the joint HarperCollins publications, an employment information service, an International Meeting, strong committees that urge greater participation from underrepresented and women scholars, or a vast array of book series. However, as many of you will know, these products have not always been a part of SBL.

Fifteen years ago, some of us would not have been able to think of SBL without a joint publishing and membership services venture with the American Academy of Religion and several other organizations. Yet we have a stronger publications program than at any time in the history of SBL, as evidenced by our associate membership in the Association of American University Presses. We have brought membership and subscription services into our operation directly, and that service has consistently received strong praise for accuracy and responsiveness.


At the 2002 SBL Annual Meeting, many of us would not have thought that the American Academy of Religion would not be present at the 2008 SBL Annual Meeting. The AAR decision, announced to us without consultation in April 2003, has been responded to by every SBL administrative committee, programmatic initiative, and staff. In fact, when AAR asked in 2005 to meet independently at the same time in San Francisco, a city we had already contracted with for 2011, we responded positively. We will work to make that meeting a success by any measure, just as we are working to have successful meetings in 2008, 2009, and 2010.

When one cannot imagine and then work with that imagination in concrete ways to respond to change, there is little hope. As we look around the corner to 2008, there will be many new opportunities for SBL to demonstrate once again that we are capable of providing effective publications, congresses, technological initiatives, and professional development programs to better address the needs of our members and our disparate audiences.

#### Religious Leaders

In 2008, we will continue our series of lectures and workshops for religious leaders. We began these at Christian Theological Seminary in Indianapolis, where we began with the theme "Engaging the Bible in the Contemporary Discussions of Marriage." SBL leaders discussed the biblical resources regarding the contentious debates in American life surrounding marriage. The type of questions asked and answered were: How do we use the Bible to assist in discerning the biblical perspectives on marriage? Can the Bible only serve to divide people, or can it serve a role in pursuing a line of ennobling civil discourse?

At Wesley Theological Seminary we continued with the theme "Engaging the Bible—Politics, Media, Human Rights, and Family." The questions addressed included: How is the Bible being used in political discourse?

#### Teaching the Bible in Public Education

The Council named a working group to respond to some of the new demands for teaching the Bible in public education. That task force, along with SBL staff, is working to develop resources for high school teachers. We have had the advantage of already publishing a variety of teaching tools. Our two *Teaching the Bible* volumes (see the new publications for the most recent of these volumes) as well as the HarperCollins volumes and our Resources and Writings series have prepared us well to move into this new market of secondary school teaching tools.

We have also begun to create partnerships with organiza-

tions that deal with the first amendment issues that are so integral to the teaching of sacred texts in public education. Council joined a wide range of organizations by endorsing *The Bible and Public Education—A First Amendment Guide* (http://www.sbl-site.org/assets/pdfs/BibleGuide.pdf).

#### Refining and Expanding our Publications

The success of the SBL publications program comes from two strategies: (1) a constant review and evaluation of the way we are publishing; (2) the establishment of partnerships that serve the needs of both the SBL and the partnering entity.

The recent decision to provide digital access to *JBL* emerged from the review and evaluation strategy. The decision to move all book reviews to *Review of Biblical Literature* 

(www.bookreviews.org) came about from that process as well. The Editorial Director, publications staff, and Research and Publications Committee are currently reviewing the way our book series are organized. The goal is to encourage potential authors to easily identify places they would like to see their books published. In addition, we need to make certain that purchasers, especially libraries and resellers, can easily identify what constitutes a series. Our most successful series, measured in several ways, are those that are content based. So series such as Writings from the Ancient World and Writings from the Greco-Roman World are easily

spotted, whereas the series that are "genre" based, such as the dissertation series Academia Biblica, have a tendency to be less successful. Of course, there are many dynamics that influence the success of a series. In any case, we will continue to evaluate and review what we are doing in publications.

Our publications have also kept up to the rapidly changing publication technologies. By knowing where and how the production processes are advancing, we can make every effort to provide our purchasers with an outstanding product at the lowest possible cost. This goal is an important one in an increasingly competitive market.

The second strategy that we have employed is that of forming partnerships that provide advantages to both SBL and the partner. The arrangements made over thirty years ago with HarperCollins was one of the first such partnerships. The publication of the *Harper's Bible Dictionary* in

1985 (now called the *HarperCollins Bible Dictionary*) was a product our publications program could not have created by itself. The publishing agreement with Brill is another example of arriving at a creative new way for SBL and Brill to work together. Now we have extended this arrangement by our publication of select Brill titles in paperback.

An arrangement in late 2006 with Sheffield Phoenix Press (SPP) established a new partnership. Volumes published by Sheffield Phoenix Press are readily accessible to SBL customers, since SBL is functioning as SPP's exclusive North American distributor. As a result of this arrangement, North American customers have more options for securing SPP titles than ever before; in addition, members are able to order or purchase SPP books through a favorite bookseller, and scholars and students are able to purchase any SPP title directly from the SBL at the same price as from SPP. Because the SBL maintains an inventory of all SPP titles, buyers no longer face the added costs and frequent delays of overseas shipping. In addition, since the SBL represents SPP titles at various North American meetings, attendees are able to examine (and purchase) SPP books much more regularly and frequently than has been the case in the past. SPP also represents SBL books at various U.K. and European conferences, which makes SBL titles more accessible to our colleagues overseas.

Members and all those interested in SBL publications will see new partnerships and the results of careful review and evaluation. Sneaking in one more comment, notice the bold, striking new covers on our books. The covers are matched by the striking contents found inside.

#### Congresses

No SBL program has required us to imagine more clearly, more seriously, or more precisely than our annual meetings in North America. From the moment that SBL was told that the American Academy of Religion would not be meeting at the same time and place as we were meeting, we have relied upon our values to drive every decision. That includes the decision to agree to meet again together in 2011 when they asked if that was agreeable to us.

We could not assume that nothing would change between the time we were told of the decision through to the planning of AM 2011. Therefore, we have put in place a series of new strategies.

First, we are scheduling meetings in cities that members have always indicated are preferred, such as Boston, New Orleans, Atlanta, San Francisco (we signed contracts before AAR asked to meet at the same time and place), Chicago, and now Baltimore (2013). These cities also provide rates and other financial factors that will make it possible for us to plan meetings at costs as low as, if not lower, than in the past.

Second, we have reviewed the primary drivers that make our meetings successful. They include the opportunity to meet colleagues who teach and do research across the study of antiquity, archaeology, religion, theology, ethics, ancient Near East, and comparative studies across humanities scholarship. So we have been and are working very hard to make sure that the related and affiliated organizations continue to meet with us. Our Program Committee has expanded the program units so that colleagues who have wanted to share ideas with SBL members can have that opportunity. The exhibit hall has always been a place where our members buy books and meet colleagues. We have been working with the publishers and software companies to let them know the importance of their exhibiting. We have adapted our staff to include a new person who understands the needs of exhibitors and who has been working in the exhibiting business for a dozen years.

Third, we know the importance of career services for higher education institutions and people looking for employment. Therefore, we have committed ourselves to having a better mechanism for employer and potential employees to come together. This can only happen through a more effective and efficient online service and the implementation of better ways for potential employees to let an employer know about their backgrounds and skills and for employers to have a place of record for advertising positions in their institutions.

Finally, we have reviewed all of the operational procedures for the meeting, from proposing and reviewing papers to registering and booking hotels. We have developed and regularly refine an online system for the paper proposal and review process. We have reduced the cost of registration and housing by bringing these operations in-house. Yes, we have expended (namely, capitalized) funds to develop these operations, just as we did when we brought membership and subscriptions in-house several years ago. We tested the registration and housing system at our Vienna 2007 meeting, and it worked beautifully for over 800 registrants. The fact that we have been involved in the development of congresses for twenty-five years with our international meeting has served us well in looking toward the future of our congresses.

#### International Community of Scholars

From early in the life of SBL, leaders have looked around the corner. The establishment of the American Schools of Oriental Research, the energy of key leaders in SBL to assist in the foundation of the new AAR, and even a modest role now in working together with an organization that was founded in opposition to SBL, the Evangelical Theological Society, has demonstrated the capacity of an evolving organization to imagine.

From the beginning of the twentieth century SBL demonstrated the ability to imagine an international organization. Some international colleagues became members, and then SBL recognized the importance of this connection and developed a category of honorary member, a category we no longer need because of the 2,000 international members. Today we not only meet regularly outside North America but have leaders in key positions from outside North America. From our founding with seven people in a small New England study to a global effort to learn from others and to share our resources, this has become our hallmark.

In our second century we have learned that services for members is essential, but, most importantly, we have come to understand the power of building an international community of scholars. This community is extended through the virtual world, concrete face-to-face meetings, and print media.

What vision of 2020 will enable us to imagine things we have not yet come to expect of ourselves?

#### A Change in the Journal of Biblical Literature

The Editor of the *JBL*, James VanderKam, announced, with the full support of the Research and Publications Committee and Bob Buller, Editorial Director of SBL, that the *JBL* will no

longer have a book review section. The *Review of Biblical Literature* will now be the book review organ of the SBL. Reasons for this decision include the following.

- 1. The *RBL* provides wider and swifter coverage of books published. *JBL* has typically included 50 to 60 reviews per year, while *RBL* publishes from 450 to 500 per year. *RBL* is able to make reviews accessible almost immediately upon reception of them, while there is a lengthy delay in print publication.
- 2. There has been a significant overlap between the reviews published in *JBL* and *RBL*. Roughly half of the reviews recently published in *JBL* were commissioned by *RBL* editors and published within *RBL* before their publication in *JBL*.
- 3. There is a shared pool of reviewers: Approximately 85 percent of all *JBL* reviews were written by scholars already writing reviews for *RBL*, so that *JBL* reviews have not expanded or altered the reviewer pool in a significant way.

In light of these considerations, it appears to be a wiser use of the limited number of pages available in the *JBL* to devote all of them to articles. Eliminating reviews from *JBL* will also end the duplication in reviews presently existing.

The availability of more space for articles should also reduce the amount of time that elapses between the acceptance of an essay and its publication.

#### Enhancing JBL Access

Early in 2007 SBL members began having enhanced online access to the *Journal of Biblical Literature*.

Now, through MetaPress, the world's largest scholarly content host, members will be able to enjoy significant enhancements, such as

- full-text searching of all *JBL* issues beginning with *JBL* 120 (2001);
- automated table of contents and downloadable pdfs; and
- a personalized home page where members can save searches, manage saved items, set automatic email alerts, and more.

Members and non-members alike with institutional affiliation may also continue to access *JBL* through a variety of aggregates, including the ATLA Religion Database (from 1960), EbscoHost (from 1973), Literature Online (from 1999), and ProQuest (from 1997). In addition, all issues of *JBL* are archived through JSTOR, and members may access these archives either through their institutions or by logging on to the SBL site.

Although all SBL members now have free access to *JBL* via MetaPress, we encourage members to recommend that their

institutions also subscribe to *JBL* online, so that everyone, professor and student alike, can freely access the latest and best of biblical scholarship. #### Review of Biblical Literature

So far this year, 414 reviews have been published in the *Review of Biblical Literature* (*RBL*), with a total of 3,747 total reviews published to date. This year's print edition of *RBL* (vol. 9) promises to be the best ever, with 184 individual reviews and featuring the major review essays: "Orality and Biblical Studies: A Review Essay," Werner H. Kelber, Rice University, Houston, Texas (pp. 1–24), and "Israel's History and the History of Israel," by Mario Liverani, reviewed by Nadav Na'aman, Tel Aviv University, Ramat Aviv, Israel. *RBL* remains not only the SBL's most widely distributed online publication but also the premier source of biblical studies book reviews in the world.





#### Vienna Retrospective

In July 2007, the Society of Biblical Literature held their largest ever International Meeting in Vienna, Austria. We were joiloned by the European Association of Biblical Studies. Here are some of the most significant highlights of our meeting.

There were 192 sessions with 775 participants, compared to 109 sessions with 423 participants in 2006. That is a 76 percent increase in sessions and an 83 percent increase in participants over 2006.

Eighty-nine percent of registrants presided or presented at the meeting. There were two



new continuing program unit sessions, Mind, Society, and Tradition and Biblical Greek Language and Linguistics.

Registrations totaled 812, not including cancellations. This represents a 30 percent increase over the 2006 meeting in Edinburgh, our previous high. Twenty-nine percent of registrants were from the United States, 15 percent from Germany, 11 percent from United Kingdom, 7 percent from Austria, and the remainder from nearly 40 other countries. Registrations over the web continue to outnumber other methods by over 70 percent.

Our advertising numbers increased this year from fifteen to eighteen, an increase of 20 percent.

#### SBL 2007 Regional Scholars

#### Central States Regional Scholar

Eric F. Mason is Associate Professor of Biblical Studies at Judson University, Elgin, Illinois, and teaches in the areas of New Testament and Second Temple Judaism. He holds a Ph.D. in Christianity and Judaism in Antiquity from the University of Notre Dame, an M.Div. from Beeson Divinity School, Samford University, and a B.A. from Union University. Mason was selected as a Regional Scholar by the Central States Region for his paper titled "Melchizedek in Hebrews and the Dead Sea Scrolls," and he will present a revised version of the paper at the 2007 Annual Meeting. His monograph on priestly messianism in the Epistle to the Hebrews and Second Temple Jewish literature will be published by Brill, and he is co-editing a Festschrift that will appear in 2008. He is an associate editor for the journal Henoch: Studies in Judaism and Christianity from Second Temple to Late Antiquity.

#### Eastern Great Lakes Regional Scholar

Lee A. Johnson is an Associate Professor of New Testament at the Methodist Theological School in Ohio. She graduated with a Ph.D. in Biblical Studies from the University of St. Michael's College in the Toronto School of Theology, where she was also taught courses in New Testament and Greek. She has published articles in Catholic Biblical Quarterly and Biblical Theology Review and has contributed to the ESCI series by Wilfred Laurier Press on Religious Rivalries and the Struggle for Success in Caesarea Maritima. She is a member of the Context Group and is completing an article on the relationship between pneumatic gifts and the authority of women in the Pauline communities, using a cross-cultural comparison between glossolalic women in modern worship communities and the women at Corinth. She is also currently completing a manuscript entitled "The Epistolary Apostle: Paul's Response to the Challenge of the Corinthian Congregation." Lee presented "An Examination of Funk's Apostolic Parousia in the Corinthian Correspondence: The Impact of the Epistolary Apostle" at the SBL Eastern Great Lakes regional meeting in March 2006.

#### Mid-Atlantic Regional Scholar

Jeremy Schipper (Ph.D., Princeton Theological Seminary, 2005) is a Lecturer in Hebrew Bible at Temple University in Philadelphia. Before coming to Temple, he taught for two years at Siena College near Albany, New York. His research has focused on the Former Prophets as well as disability in the Hebrew Bible and cognate literature. It has appeared in

JBL, JSOT, VT, and CBQ. He is the author of Disability Studies and the Hebrew Bible (T&T Clark, 2006) and the co-editor with Hector Avalos and Sarah Melcher of This Abled Body: Rethinking Disabilities in Biblical Studies (Society of Biblical Literature, 2007). Schipper serves as the co-chair with Rachel Magdalene of the Disability Studies and Healthcare in the Bible and Near East SBL program unit. He received the Regional Scholars Award for a paper subsequently published under the title, "Did David Overinterpret Nathan's Parable in 2 Samuel 12:1–6?" (JBL 126 [2007]: 381–89). Portions of this paper will appear in his next book, which is tentatively titled "Proverbs of Ashes": Conflict and Parables in the Hebrew Bible. This book will examine the relationship between parables, genre, and conflict in the Hebrew Bible.

#### Pacific Northwest Regional Scholar

Michael Heiser earned an M.A. in Ancient History from the University of Pennsylvania (major fields: Syria-Palestine and Egyptology) and the M.A. and Ph.D. in Hebrew and Semitic Studies at the University of Wisconsin-Madison. His dissertation was entitled "The Divine Council in Late Canonical and Noncanonical Second Temple Jewish Literature." The dissertation sought to demonstrate the acceptance of divine plurality in Judaism into the Common Era and the Canaanite/Israelite roots of first-century Jewish monotheism's notion of two powers in heaven. Mike's paper submitted for consideration as a regional scholar was entitled "Are Yahweh and El Distinct Deities in Deut 32:8-9 and Psalm 82?" The paper was read at the 2006 Society of Biblical Literature's Pacific Northwest regional meeting and was subsequently published online in the scholarly journal HIPHIL. Mike is currently the Academic Editor for Logos Bible Software. He is responsible for targeting and evaluating potential data projects for scholarly products dealing with primary texts related to the languages of the Bible and the ancient Near East, overseeing scholars who are participating in team data projects for Logos, and creating content for the Logos platform. Before coming to Logos, Mike taught on the undergraduate level for twelve years.

#### Southeastern Region Regional Scholar

Susan E. Hylen is Mellon Assistant Professor of New Testament at Vanderbilt University. She has a Ph.D. from Emory University and an M.Div. from Princeton Theological Seminary. The author of two books on the Gospel of John, her current research focuses on characterization in the Gospel. Susan presented a paper entitled "Metaphor and Ethics in Revelation" at the Southeastern regional meeting (SECSOR).

#### **2007 Travel Grant Recipients**

Mercy Itohan Idumwonyi, Nigeria, is currently Assistant Lecturer in Religion with a specialization in Old Testament studies at the University of Benin in Benin City, Nigeria. She received her B.A. (1998) and M.A. (2002) in Religious Studies from the University of Ibadan, Ibadan, Nigeria. Her professional experience includes work as a research fellow for the Centre for Democracy & Development in Benin City and a year as Senior Program Officer for the African Women Empowerment Guild, also in Benin City.

Micheline Kamba Kasongo, Democratic Republic of the Congo, is currently a Ph.D. student in Theology at the University of Kwa- Zulu-Natal (UKZN) in South Africa. She holds the equivalent of a B.A. in Theology from l'Université Protestante Au Congo (UPC) and both an M.A. in Theology and an M.A. in Education from UPC. 
#### Report of Independent Auditors

- Publish biblical scholarship


#### **International Cooperation Initiative**

The initial contour of an initiative to become more responsive to the needs of our international constituents is being developed. After a couple years of conversation with international colleagues, culminating in a meeting at the 2007 Vienna International Meeting, Ehud Ben Zvi has drawn together the following strategies. Leigh Andersen is the staff person working directly with the group, since many of the items are related to publication issues.

- 1) SBL will provide free electronic access to selected SBL publications to scholars and students in countries whose Gross Domestic Product (GDP) per capita is substantially lower than the average of the GDP per capita of the USA and the European Union.. SBL Publications staff will oversee the selection of material that is commensurate with the international needs. A computer system that will allow identification by geographical IP address will be in place by very early in 2008 (in final testing now).
- 2) The SBL will establish a new series to electronically publish scholarly work originating in the developing world. The series is tentatively called "Voices from [Africa, South America, Eastern Europe, Eastern Asia, South Pacific]" depending on the source of the work. Works in this series will be accepted in English and/or the native language of the author. This series can be in place in time to publish papers from international meetings in New Zealand and Korea. Collections of papers from the meetings envisaged in (7) below may be included in this series.
- 3) SBL is identifying local groups (publishers, libraries, consortia of institutions or academic societies) to facilitate local print production of SBL books, including volumes in the series "Voices from . . .".
- 4) JSTOR currently provides free access to universities in Africa. SBL is working with JSTOR to encourage similar pro-

grams in other under-resourced areas of the globe by the end of 2008.

- 5) SBL is investigating the establishment of databases that can be accessed through the SBL web site and will facilitate faculty cooperation, including exchange and co-supervision among scholars and institutions in different parts of the world. SBL technology department is currently researching ways in which this can be achieved. The goal is to develop the databases shortly after mid-2008.
- 6) SBL is providing and will expand support for existing or emerging national and regional scholarly associations or groups in countries whose GDP per capita is substantially lower than the average of the GDP per capita of the USA and the European Union. SBL's expertise for planning scholarly meetings has been and will be shared with these associations and groups. SBL will act as a consultant and not provide funds for these meetings.
- 7) Publicize national and inter-regional (e.g., Western-African, Caribbean, Andean) meetings of the societies or groups mentioned above on the SBL website. There is currently a calendar on which meetings are posted; a monthly synopsis of global meeting opportunities can be provided on the SBL Forum that would encourage worldwide participation. The addition of this feature is being incorporated into the web site redesign that is almost operational.
- 8) Authors of papers presented in these meetings, as well as those from the SBL Annual and International Meetings, will be encouraged to make them available on the SBL web site. The posting of papers will begin with the 2007 Annual Meeting.
- 9) SBL complimentary memberships will be extended as financially feasible to those in developing countries. SBL complimentary memberships may be able to be provided to those who join the local organizations. The framework for managing parts of the strategy is in place and needs to be enhanced over the next twelve months.



#### HUMANITIES ADVOCACY DAY March 3-4, 2008

Humanities Advocacy Day (HAD), the ninth annual meeting in Washington, DC, will be held on Monday, March 3, at George Washington University and Tuesday, March, on Capitol Hill.

Humanities Advocacy Day is organized by the National Humanities Alliance to promote federal support for scholarly research, education, public programs and preservation in the humanities. The event provides an important opportunity for advocates to communicate the public value of the humanities to policymakers in Washington, DC. Next year's advocacy day is again being held in conjunction with the Annual Membership Meeting of the Alliance as part of the second National Humanities Alliance Conference.

#### SBL Website Redesign

SBL has had three major site redesigns (in 2000, 2001, and 2003) since launching the first independent SBL website in 1999. The proliferation of society projects and initiatives, growth in publications and meetings, as well as technological advances all prompted the realignment of our web presence.

In an effort to make navigation as intuitive as possible, several major changes were utilized in the 2007 design.


The site is broken up into the major functions of the Society: publications, meetings and events, membership, career services, and educational resources. Each of these sections has a home page where the staff and volunteers who work in these areas can feature different projects and members can accomplish their online tasks as efficiently as possible.

The inclusion of more images serves to break up the heavy text base of the site. Content boxes will make it easier to feature content "bites." Utilities at the top and bottom of the page offer an alternative navigational tool, and an effort has been made to ensure that there are always several ways to get to any information.

This redesign also optimizes search engine recognition of the content on the site. We are utilizing the Google Search Appliance for the first time. We are very pleased with the increased accuracy of the search function. The search is set up to search the SBL website, the bookstore, and the *Review of Biblical Literature* website.

The SBL technology team continues to work together to make the SBL website a useful and elegant tool for SBL members as well as a portal site for those people interested in the critical study of the Bible to find resources and information.

Thanks to Missy Colee, Lauren Hightower, Chris O'Connor, Tim Kromer, Chris Hooker, Sharon Johnson, and Samantha Sptizner, who have all contributed unique talents to the project. Enjoy using our new site and let us know what you think.

Slight Revenue and Expense Increase Projected for 2007-2008 Budget

The 2007–2008 operating budget reflects a small percentage of increase over the final 2006-2007 audited revenues and expenses. Included in the expenses are very modest increases for staff salaries, an across the board percentage increase for supplies, a print newsletter, and some much needed assistance in accounting for human resources. We have projected stable revenues in book sales and slight increases in membership and subscription revenues. The capitalization of expenses for bringing meeting registration in-house is reflected in this budget expense. The Finance Committee and Executive Director review monthly and quarterly financial reports to track the relationship of the budget to actual figures. Accounting has developed a much more detailed budget process that should assist with more precise monitoring.

Membership revenues still account for less than 20 percent of the total budget, so it is very important to make the case for contributions to the Society Fund each year. The Development Committee will be drawing up a new case statement for Council to review during calendar year 2008. This case statement will set out the significant needs of the Society for the next one, five, and ten years.
